General Terms and Conditions.

1. The Interested and eligible bidders / firms registered with the Income tax, Sales tax department and having enough experience in the field, can collect the bidding documents / BOQ from the office of undersigned on any working day up to the last date of submission of bids.
2. The bidder must have active status on ATL for all applicable taxes.
3. The bidders are required to apply by providing an application and tender document fee of Rs. 2500/- (non-refundable). Payable in the name of Chief Executive Officer WSSP, Bank of Khyber (BoK) A/C# 0742-3.
4. Two per-cents (2%) Bid Security of the total bid cost must be accompanied with the tender document in the shape of call deposit / demand draft from any scheduled bank in the name of Chief Executive Officer WSSP Peshawar.
5. The First Pre-bid meeting will be held on **21st August 2019 at 03:00 Pm**, the aim of 1st pre-bid is to educate bidders regarding WSSP uniform and allied items.
6. The Second Pre-bid meeting will be held on **29th August 2019 at 3:00 pm**, the aim of 2nd pre-bid meeting is to review and finalize the samples provided by the participating bidders, so that any confusion in submitting the bid shall be avoided.
7. **The Interested parties are advised to attend the Pre-bid meetings which is Compulsory.**
8. Sealed bids duly stamped and signed shall reach the office of the undersigned up to **11:00 AM on 5th September 2019 and will be opened on the same day at 11:30 AM** in the presence of Supplier or their authorized representatives.
9. The rate quoted must be inclusive of all duties / taxes as per directives of the government issued from time to time and delivery at site with in WSSP Jurisdiction.
10. Any disfiguring / over writing, manipulation in the tender shall be liable to rejection or Incomplete / conditional / late submitted bids shall not be acceptable.
