Notice Inviting Tender for Procurement of Solid Waste Containers.

Water and Sanitation Services Peshawar (WSSP) has been established by Government of Khyber Pakhtunkhwa and formally registered under Section 42 of Companies Ordinance 1984 to provide integrated and yet improved drinking water, sanitation and solid waste management services in district Peshawar.

Sealed tenders under Single Stage two Envelop Producer of KPPRA Rules 2014 are hereby invited from Income tax and Sales tax registered Manufacturers / Fabricators having registration with PEC in category C-6 or above and having code ME-06 for work titled, **“Procurement of Solid Waste Containers”** for WSSP.

General Terms and Conditions.

1. Interested and eligible bidders, registered with the Income, Sales tax department / KPRA and having sufficient experience in the field may apply. The tender documents / BOQ shall be issued to the bidders on submission of application and tender document fee through Bank Cash deposit slip of Rs. 3000/- (non-refundable). Payable in the name of Chief Executive Officer WSSP, Bank of Khyber (BoK) A/C# 0742-3.
2. Two per-cents (2%) Bid Security of the total bid cost must be accompanied with the financial proposal in the shape of call deposit / demand draft from any scheduled bank of Pakistan in the name of **Chief Executive Officer WSSP Peshawar**.
3. Sealed Proposal (Technical and Financial) duly stamped and signed shall reach to the office of the undersigned up to **11:00 AM on 30-09-2019 through Courier Service and will be opened on the same day at 11:30 AM** in the presence of Supplier or their authorized representatives.
4. Pre-bid meeting will be held on **24-09-2019 at 11:30 am** at the address mentioned below.
5. Any disfiguring / over writing, manipulation in the tender shall be liable to rejection or Incomplete / conditional / late submitted bids shall not be acceptable.
6. The rate quoted must be inclusive of all federal and provincial duties / taxes including KPRA Taxes, as per directives of the government issued from time to time.
7. The bidder must be a Registered Entity with KPRA Rules 37A.
8. The Bidder will be required to paint container as per WSSP Colour, design the bidder will be required to Emboss WSSP and logo on containers.
9. The Pre-delivery inspection of WSSP inspection team of 3-4 persons shall be the responsibility of the bidder (Boarding, lodging etc.)
10. The Competent Authority reserves the right to reject anyone or all the tenders, the reason for rejection shall be communicated to the contractor/ firm upon request.
