3. Quoted rate must be inclusive of delivery at site, Fitting of Tyres with wheel balancing and alignment. Tyres Should be supplied out of Fresh Stock else will be rejected.
4. All Govt. taxes and duties, provincial duties & taxes / stamp duties including sales tax / KPRA taxes will be recoverable as per directives of the government issued from time to time.
