4. 2% bid security of total cost in the shape of call deposit / Demand draft in favor of **Chief Executive Officer; WSSP** must be accompanied with the bid.

The Sealed bids must be submitted till 11:00 am (SHARP) on 29-05-2020 through Registered Courier Service and will be opened by Bid preparation and evaluation committee on the same day at 11:30 am at the below mentioned address in the presence of the bidders or their authorized representatives, who chooses to attend.

6. **In order to implement the contract effectively in Zone A, B,C,D. One Bidder will be allowed to participate and award contract for one Zone only.**
