The Sealed proposals complete in all respect under single stage two envelope procedure of KPPRA Rules 2014 (Technical / Financial) shall reach to the office of the under sign up to Tuesday 17th November, 2020 till 11:00 am, late submitted proposals shall not be accepted. The submitted proposals shall be opened on same day at 11:30 am by WSSP Committee. The proposals shall be clearly marked as "Consultancy Services For Feasibility Study to Rehabilitate STPs constructed earlier in Peshawar, Kohat and Bannu". The sealed "Technical Proposals" will be opened on the same day at 11:30 am whereas the date for the opening of "Financial Proposals" shall be communicated after technical evaluation to all participating bidders.
- 5. The Pre-bid meeting will be held on Wednesday **4**th **November 2020 at 02:30 pm** in the conference room of WSSP at venue mentioned below.
- 6. All federal and provincial duties / stamp duty / taxes including KPRA taxes will be recoverable as per directives of the government issued from time to time. The firm must be a registered entity with KPRA. (Rule: 37A of KPPRA).
- 7. The Consultant / Firm providing unsubstantiated, false information and any disfiguring / over writing, manipulation in the proposal shall be liable to rejection / disqualification at any stage.
