Notice Inviting Tender

Water and Sanitation Services Peshawar (WSSP) has been established by Government of Khyber Pakhtunkhwa and formally registered under Section 42 of Companies Ordinance 1984 to provide integrated yet improved drinking water, sanitation, and solid waste management services in district Peshawar. WSSP invites sealed tender from registered suppliers / manufacturers for **Supply of Tools & Equipment for Sanitation activities of Zone B & C WSSP** as per following terms and conditions.

1. The Bidding Soliciting Document may be obtained by the interested and eligible bidders having KPRA Registration on the submission of a written application and upon payment of a (non-refundable) fee of Pak. Rs. 2000/- Payable in the name of Chief Executive Officer WSSP, Bank of Khyber A/C# 0742-3 Phase –III Chowk Hayatabad till Tuesday **2nd March 2021**. The Bid Soliciting documents may be downloaded from WSSP website, in the case document fee slip of Rs. 2000/- must be enclosed with Bid.
2. The Bids must be delivered through Registered Courier Services to the address below on or before **2nd March 2021 up to 11:00 AM**. Bids will be opened on the same day on **11:30 AM** in the presence of the Bidder's representatives who choose to attend at the address below.
3. All Bids must be accompanied by a Bid Security of **2%** of the total bid price in Pak Rupees in the form of Call deposit in the name of **Chief Executive Officer Water & Sanitation Services Peshawar**.
4. **The Pre-bid meeting will be held on Monday 22nd February 2021 at 03:00 pm; where each Bidder shall show the Sample of Sanitation tools and Equipment as mentioned in BOQ. Else the Supply from successful bidder will be subjected to approval of sample at the respective Zonal offices.**
5. The Bid must be Stamped and Signed by the Suppliers/Manufacturers or authorized person of the firm. All federal and provincial duties/stamp duty/taxes including Sales tax / KPRA taxes will be recoverable as per directives of the government issued from time to time.
6. Any disfiguring / over writing, manipulation in the tender shall be liable to rejection. Incomplete / conditional and late bids shall not be acceptable, other detailed terms and conditions are available with the bid soliciting documents.
7. The Competent Authority reserves the right to reject anyone or all the bids, the reason for rejection shall be communicated to the Contractor / firm upon request.
