2. To ensure timely completion of work it is mandatory that contractor / bidder who wins more than one Package should ensure availability of Boring Machinery at all sites and should start work at once.
3. The Contractor Quoting their bids more than 10% below on the Engineer's Estimate shall submit an Additional Bid Security equal to 8% of the Bid cost along with 2% bid security at the time bid submission in the shape of call deposit in favor of **Chief Executive Officer: WSSP**.

The bids must be submitted through Courier Services on the address mentioned below on or before 11:00 Am (SHARP) **on 1st June 2021** and will be opened by Bid preparation and evaluation committee on the same day at 11:30 Am in the presence of the bidders or their authorized representatives, who wishes to attend. Bid received after closing time shall not be entertained.

All federal and provincial duties/stamp duty/taxes including KPRA will be recoverable as per directives of the government issued from time to time.
